THIS MAKEUP AND HAIR SERVICE CONTRACT is made and entered into as of _____, by and between ("Bride") _____ whose address is _____. In consideration of the mutual covenants herein contained and intending to be legally bound hereby the Client and Lisa Brown agree as follows:

1) Makeup Artist's obligation to give service hereunder is subject to the unavailability of the Artist and result of sickness, accidents, loadshedding and acts of God and other reasons beyond the Artist control.

2) **LOCATION of WEDDING.** The wedding prep will take place at the following location:

3) CONSULTATION/MAKEUP TRIAL:

• Unless another arrangement has been made with Lisa Brown, the trial will be held as close to the wedding day as possible on mutual convenient times for both Lisa Brown and the Bride.

• Any further trial(s) requested by the Bride shall attract additional charges to be settled in accordance with these terms and conditions.

• Location of Consultation/Makeup Trial: Central Stellenbosch/Technopark or Upington

• **All trials ONLY takes place in Lisa Brown Int Studio.**

• In the case of unforeseen circumstances should it not be possible for Lisa Brown to attend the makeup trial, she will postpone and reschedule the appointment.

• **BRIDE ONLY FOR TRIALS.**

• The average time for a trial is 2-2 and a half hours (Maximum)

4) DATE and TIME of WEDDING: The date of the Wedding:

• It is the responsibility of the bride, who must ensure that her bride's maids, mothers, sisters and/ of friends receiving any services in terms hereof does the same, to:

• Properly wash their hair on the day prior to- or on the morning of the trial and wedding day.

- Not receive any skin treatments (such as facials, chemical peels and the like) within 14 days of the wedding day as it could possibly lead to unnecessary skin irritations and break-outs that could ruin the make-up on your wedding day.

- **5) PAYMENT:**

In full consideration for all services rendered by Lisa Brown at the location the

- 50 % non- refundable Deposit: Client will pay _____

- This fee is not- refundable and non-transferable. In the booking total (in terms of hair, makeup, trial and extras, In respect of brides, bridesmaids or guests) is less than R4500 the full amount is due as the booking fee. Booking fee payment will cover and secure the following : Admin services, arrangements around the wedding day, securing of the services of head makeup artist (Lisa Brown) and assistants (if needed) for the specific wedding date specified.

- Payment method: EFT (no cash deposits)

- Payment of Balance: must be paid one month prior to the wedding day. Date will be stated in invoice. **(If the full amount has not been received 7 days prior to the wedding day, the hair and makeup will be cancelled and no refund will be given).**

- **Deductions: Once you have accepted the quotation and payment has been made no deductions can be made from there on forward.**

Travel Rate: R5.00 per km will apply for traveling outside of Somerset West (Sitari Country Estate – Lisa’s house). **Cost subject to AA rates**

- **Consisting at least x5 faces to be painted, If only the bride or less than 5 faces to be painted a day rate will be applicable.**

- **Lashes an optional choice.**

- **Refreshments and light lunch would be greatly appreciated if working more then 2 hours on your wedding day. (This includes assistance when booked)**

6) ADD- ONS

Add-ons to the quotations must be made two to three weeks prior to the wedding date

- **CANCELATION:**

- Four months’ notice should be given upon cancellation of the quotations, otherwise you will be held liable for the full payment. No alteration or variation this agreement any communication is required to be in writing, the term “writing” shall include communication be email and whatsapp.

8) CONFIDENTIALITYCLAUSE:

The Receiving party agrees that they will not, during or after the course of its relationship with the disclosing party, under this agreement and/or the term of this agreement, disclose confidential information to any

third party for any reason or purpose whatsoever, without the prior written consent of the disclosing party and to the extent of such authorisation, save in accordance with the provisions of this agreement.

In this agreement “third party” refers to any party other than the receiving party and disclosing parties or their representatives. The terms of this agreement are to prevent unauthorised disclosure of the confidential information to third parties.
