MAKEUP AND HAIR CONTRACT

This **Makeup and Hair Service Contract** ("Contract") is made and entered into as of _____, by and between the Client ("**Bride**") _____ and Lisa Brown, whose business address is Technopark Stellenbosch.

In consideration of the mutual promises contained herein and intending to be legally bound, both parties agree as follows:

1) Scope of Service

Lisa Brown and her team will provide makeup and/or hair services for the Bride and other members of the bridal party as agreed upon. Services include makeup application, hairstyling, and touch-ups as specified in the package selected.

2) Booking and Confirmation

Non-Refundable Deposit: A **non-refundable deposit** of 50% is required at the time of booking to secure the wedding date.

Final Balance: The remaining balance must be paid in full no later than one month before the wedding day.

Payment Method: All payments are to be made by EFT. No cash payments are accepted except for last-minute add-ons.

Failure to Pay: If the full amount is not received seven days prior to the wedding day, the makeup and hair services will be canceled without refund.

4) Consultation / Makeup Trial

All makeup and hair trials will be conducted at Lisa Brown's Studio, located at Technopark Stellenbosch.

In the event that Lisa Brown is unavailable for the trial due to unforeseen circumstances, she will reschedule the appointment at her earliest convenience.

Only the Bride is recommended to attend the trial for a focused consultation.

5) Travel Fees

A travel fee of R7.00 per kilometer will be applied for locations outside Somerset West (Sitari Country Estate).

Travel fees are based on current AA rates and are subject to change.

6) Late Arrivals and Overtime

Late Arrivals: Delays caused by late arrivals may result in reduced service time or incomplete services without affecting the payment terms.

Overtime Fees: An hourly rate of R1000 applies if the makeup and hair service time extends beyond the agreed-upon schedule.

7) Cancellation and Refunds

Cancellation Policy: If the Bride decides to cancel the contract, a four-month notice is required. Cancellations without this notice will incur full payment liability.

Refund Policy: The deposit is non-refundable. Refunds are only provided if Lisa Brown is unable to provide services due to personal illness or other unforeseeable circumstances and a replacement cannot be arranged.

8) Health and Safety

Client Health Conditions: The Bride must inform Lisa Brown of any skin conditions, allergies, or sensitivities to avoid adverse reactions.

Sanitation Protocol: All brushes, tools, and products will be sanitized before each application. Disposable applicators will be used for hygiene purposes as needed.

10) Food and Team Requirements

- The Client agrees to provide sufficient meals for Lisa Brown and her team on the wedding day.
- Scheduling of makeup and hair services for timeline will not be finalized more than four months in advance of the wedding date to allow for any necessary adjustments.

11) Photographic and Social Media Release

- By signing this Contract, the Client grants Lisa Brown permission to use photographs taken of the final makeup and hair looks for portfolio, marketing, and social media purposes. If privacy is preferred, the Client should communicate this in writing prior to the event.

12) Confidentiality Clause

- The Client agrees not to disclose any confidential information about Lisa Brown or her business and understands that any unauthorized sharing of confidential information or defamation of Lisa Brown's services is considered a breach of contract.

13) Liability Waiver

- Lisa Brown is not responsible for any allergic reactions or adverse skin reactions that may occur as a result of product use, provided all disclosed allergies and sensitivities have been considered.

14) Force Majeure

- Lisa Brown shall not be held liable for failure to perform due to circumstances beyond her control, including but not limited to natural disasters, extreme weather, or government actions.
